Instructions: City of Gardena per Resolution 6059 has adopted the California Uniform Public Construction Cost Accounting Act, (Public Contract Code Section 22000 et seq.). This Act is commonly referred to as “The Informal Bidding Act”. In accordance with the Act, the City will maintain a list of qualified contractors who may be asked to informally bid on any public works project valued up to \$200,000 that pertains to their area of expertise.
