ORDINANCE NO. 1784

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF GARDENA, CALIFORNIA, AMENDING SECTIONS 10.28.290 AND 10.28.386 AND ADDING SECTION 10.28.387 OF THE GARDENA MUNICIPAL CODE TO ESTABLISH RESTRICTED PARKING ZONES ON CERTAIN STREETS IN THE CITY

WHEREAS, residents in certain areas of the City have requested that parking, at certain times, be limited in those areas to holders of parking permits issued in accordance with Chapter 10.28 of the Gardena Municipal Code; and

WHEREAS, the areas proposed for restricted parking at all times are 132nd Street from Van Ness Avenue to Cimarron Avenue; Haas Avenue from 132nd Street to 129th Street; Daleside Avenue from 132nd Street to 129th Street; Cimarron Avenue from 132nd Street to 129th Street; 129th Street from Haas Avenue to Cimarron Avenue; the west side of Van Ness Avenue from 132nd Street to 134th Place; 134th Place from Van Ness Avenue to Purche Avenue; Daphne Avenue from 134th Place to the dead end; and 134th Place from Van Ness Avenue east to the dead end; and

WHEREAS, the area proposed for restricted parking from six p.m. to six a.m. Monday through Sunday is Spinning Avenue from 132nd Street to 134th Place; and

WHEREAS, the City Traffic Committee has reviewed the requests and determined that limiting parking on the streets fronting the homes in those areas to residents would eliminate vehicular congestion and should be granted.

NOW, THEREFORE, the City Council of the City of Gardena, California, does hereby ordain, as follows:

SECTION 1. Section 10.28.290 of the Gardena Municipal Code is amended to read as follows:

10.28.290 Special district regulations – Parking restricted in defined districts.

Except by duly issued permit, parking is unlawful where posted in accordance with the provisions of this chapter within the areas designated as follows:

A. District No. 1.

1. No parking between the hours of seven-thirty a.m. and seven-thirty p.m., Monday through Friday, holidays excepted.

- 2. No parking between the hours of seven-thirty a.m. and four p.m., Saturdays and Sundays.
- B. District No. 2. No parking between the hours of seven-thirty a.m. and four p.m., except Saturdays and Sundays.
- C. District No. 3. No parking between the hours of seven-thirty a.m. and seven-thirty p.m., Monday through Friday, holidays excepted.
- D. District No. 4. No parking Monday through Sunday, except as authorized by this code.

E. District No. 5. No parking Monday through Sunday from six p.m. to six a.m.

SECTION 2. Section 10.28.386 of the Gardena Municipal Code is amended to read as follows:

10.28.386 District No. 4 described.

District No.4 is described, as follows:

That portion of land in the City of Gardena, County of Los Angeles, State of California, described, as follows:

- 1. Spinning Avenue from 135th Street to 141st Street;
- 2. Daphne Avenue from 135th Street to 141st Street;
- Purche Avenue from 135th Street to 141st Street;
- 4. 129th Street from Berendo Avenue to Budlong Avenue;
- 5. 130th Street from Vermont Avenue to Berendo Avenue;
- 6. 131st Street from Vermont Avenue to Berendo Avenue;
- 7. 132nd Street from Vermont Avenue to Berendo Avenue;
- 8. Berendo Avenue from 129th Street to 132nd Street; and;
- 9. Catalina Avenue from 129th Street to 132nd Street.
- 10. 132nd Street from Van Ness Avenue to Cimarron Avenue;

- 11. Haas Avenue from 132nd Street to 129th Street;
- 12. Daleside Avenue from 132nd Street to 129th Street;
- 13. Cimarron Avenue from 132nd Street to 129th Street;
- 14. 129th Street from Haas Avenue to Cimarron Avenue;
- 15. West side of Van Ness Avenue from 132nd Street to 134th Place;
- 16. 134th Place from Van Ness Avenue to Purche Avenue;
- 17. Daphne Avenue from 134th Place to the dead end;
- 18. 134th Place from Van Ness Avenue east to the dead end.

SECTION 3. Section 10.28.387 is added to the Gardena Municipal Code to read as follows:

10.28.387 District No. 5 described.

District No. 5 is described as follows:

1. Spinning Avenue from 132nd Street to 134th Place.

SECTION 4. The Traffic Authority is directed to erect signs in accordance with Section 10.28.360. The provisions of Sections 10.28.280 through 10.28.387 shall be enforced in the areas added by this Ordinance No. 1784 when at least two (2) of such signs are erected on each side of each street within a block.

SECTION 5. The City Clerk shall certify the passage of this ordinance and shall cause the same to be entered in the book of original ordinances of said City; shall make a minute passage and adoption thereof in the records of the meeting at which time the same is passed and adopted; and shall, within fifteen (15) days after the passage and adoption thereof, cause the same to be published as required by law, in a publication of general circulation.

SECTION 6. This ordinance shall not become effective or be in force until thirty (30) days from and after the date of its adoption.
