ORDINANCE NO. 1790

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF GARDENA, CALIFORNIA, AMENDING SECTION 13.40.010 OF THE GARDENA MUNICIPAL CODE TO ADOPT BY REFERENCE THE 2018 EDITION OF "THE STANDARD SPECIFICATIONS FOR PUBLIC WORKS CONSTRUCTION, THE GREEN BOOK."

THE CITY COUNCIL OF THE CITY OF GARDENA, CALIFORNIA, DOES HEREBY ORDAIN, AS FOLLOWS:

- SECTION 1. <u>Findings</u>. The City Council of the City of Gardena, California does hereby resolve, as follows:
- A. Pursuant to Government Code Section 50022.2 et seq., the City may adopt codes by reference provided that all procedures and requirements are complied with; and
- B. The City desires to adopt by reference the Standard Specifications for Public Works Contracts ("SSPWC") amended by the State; and
- C. This ordinance was introduced on March 13, 2018 at which time the City Council scheduled a public hearing thereon for April 10, 2018; and
- D. Notice of the public hearing was published pursuant to Government Code Section 6066; and
- E. One copy of the SSPWC has been filed in the City Clerk's office for at least 15 days preceding the hearing.
- SECTION 2. That Section 13.40.010 of the Gardena Municipal Code is hereby amended to read, as follows:
- "Section 13.40.010. <u>Adoption of Standard Specifications for Public Works Construction</u>.
- A. The rules, regulations, provisions, and conditions set forth in the publication entitled "Standard Specifications for Public Works Construction, 2018 Edition," (Green Book) including any supplements and amendments thereto, are hereby adopted as the standard specifications regulating materials of construction and their use in the erection, installation, alteration, repair, removal, conversion, demolition, and construction of public works improvements in the City, providing for the administration of contracts as well as permits issued in connection with such improvements.

B. The provisions contained in the Green Book may be superseded by specific provisions in a Public Works contract.

SECTION 3. Severability. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance. The City Council of the City of Gardena hereby declares that it would have adopted this ordinance and each section, subsection, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, sentences clauses, phrases or portions may be declared invalid or unconstitutional.

SECTION 4. The City Clerk shall certify to the passage and adoption of this ordinance and shall cause the same to be entered in the book of original ordinances of said City; shall make a minute of the passage and adoption thereof in the records of the meeting at which the same is passed and adopted; and shall within fifteen (15) days after the passage and adoption thereof cause the same to be published in a local weekly newspaper of general circulation and which is hereby designated for that purpose.
