GMC 18.58.040- Signs Allowed with Permits- Banners display duration: not to exceed 15 consecutive days or 60 total days in any twelve month period; all banners displayed on a given parcel, lot or land use shall count toward the total amount of allowable wall signage; construction standards: all banners shall be attached to a wall pursuant to subsection B(2)(b) of this section such that no banner shall impede traffic or project over the public right of way or over the property line.
