

RESOLUTION NO. 6305

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
GARDENA, CALIFORNIA, SUSPENDING THE ISSUANCE OF
PERMITS FOR SALE OF SAFE AND SANE FIREWORKS DURING
CALENDAR YEAR 2018**

WHEREAS, City of Gardena Ordinance No. 1785 has amended Section 8.16.020 of the Gardena Municipal Code to empower the City Council to suspend the issuance of permits for the sale of safe and sane fireworks; and

WHEREAS, the City Council wishes to place a moratorium upon the storage, sale, handling, and discharge of safe and sane fireworks during the period between June 28 and July 4, 2018, in order to measure its impact regarding reducing the nuisance caused to residents by the use of legal and illegal fireworks during that period.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GARDENA, CALIFORNIA, DOES HEREBY FIND, DETERMINE, AND RESOLVE, AS FOLLOWS:

SECTION 1. The issuance of permits for the sale of safe and sane fireworks for the period between June 28 and July 4, 2018, is hereby suspended.

SECTION 2. In accordance with Section 8.16.150 of the Gardena Municipal Code, it shall be unlawful for any person to sell, possess, use, or discharge safe and sane fireworks in the City during the period between June 28 and July 4, 2018.

SECTION 3. This Resolution shall be effective upon the effective date of Ordinance No. 1785 and shall expire and be of no further force and effect as of December 31, 2018.

BE IT FURTHER RESOLVED that the City Clerk shall certify to the passage and adoption of this Resolution; shall cause the same to be entered among the original Resolutions of said City; and shall make a minute of the passage and adoption thereof in the records of the proceedings of the City Council of Gardena in the minutes of the meeting at which the same is passed and adopted.


