#### RECREATION AND HUMAN SERVICES - ADMINISTRATOR'S REPORT

- A. <u>Staff Training</u> The department is receiving many new hires for the summer. All new hires will attend training on department policies and procedures during orientation.
- B. <u>Youth Sports</u> Baseball/Softball registration is being accepted. The deadline to register is June 7.
- C. <u>After School Program/Day Camp</u> Summer Day Camp begins on June 10. Full day care will be held at Johnson and Freeman Parks. Applications are being accepted to a possible third camp at Rowley Park. Staff assigned driving duties are in the process of completing medical certification.
- D. <u>Breakfast with the Easter Bunny</u> Participants enjoyed crafts, breakfast, a bubble show, and pictures with the famous Easter Bunny. Many kids attended for the Annual Easter Egg Hunt on the city hall lawn.
- E. <u>Cinco De Mayo Parade & Festival</u> Attendees enjoyed a day of fun filled activities beginning with the parade followed by festivities at Fukai Park featuring food, mariachi's, classic car show, folklorico dancing, celebrity speakers, Cinco De Mayo royal court, and more. The program was nice and well attended.

#### **ORAL COMMUNICATIONS**

Commissioner Haase asked about silent fireworks for the fireworks show. She suggested this option as a way of making the show more enjoyable and reducing the stress that the loud noises cause Veteran's with post-traumatic stress disorder (PTSD) and for dogs and cats. She said that other cities are using this method. Commissioner Mathews asked what the effectiveness of silent fireworks would be if other adjacent cities were having fireworks.

Commissioner Dyson inquired about the notification procedure for selling fireworks in the City and asked staff for a report at the next meeting.
