The regular meeting of the City Council of the City of Gardena, California, was called to order at 7:10 p.m. on Tuesday, October 22, 2019, in the Council Chamber of City Hall, 1700 West 162nd Street, Gardena, California; Mayor Tasha Cerda presiding.

Dr. Jonathan Kramer Esq., of Telecom Law Firm, gave a PowerPoint presentation.

There was a discussion which included Mayor Pro Tem Kaskanian, Council Members Henderson and Tanaka and Dr. Jonathan Kramer regarding the number of cell sites in our City and asking how close they would be to one another, if we would maintain local control; and if we have the control to stop carriers from contacting private property owners. Dr. Kramer explained that the cell sites would be close and now that we are transitioning to 5G it will work to reduce the area coverage of each cell site. He continued to say that we have the right to determine where the cell sites go and how they look; Federal and State law allows us to regulate the aesthetics; we are not allowed to say no to where and how. He continued, saying that we would have the control to stop carriers from contacting private property owners. Council Member Tanaka thanked Attorney Kranitz for looking out for us.

Raymond Barragan, City of Gardena Director of Community Development Department, gave a PowerPoint presentation.

Those who spoke in opposition of the Project: <u>Eva M. Matte</u> (resident); <u>Terri Haase</u> (resident). Ms. Haase also presented Mayor and Council with a petition signed by residents of the area in opposition of the Project.

Those who spoke in favor of the Project: <u>Margie Hoyt</u> (resident) and <u>Maria Horton</u> (representative of Garden West Estates that adjoins the subject property).

Mr. Chad Brown, Vice President of Melia Homes, thanked City Staff and then gave a PowerPoint presentation of the proposed project; and was available for any questions.

There was a lengthy discussion which included Mayor Cerda, Council Members Medina, Tanaka and Henderson, and Mayor Pro Tem, Kaskanian regarding whether an Environmental Impact Report had been done and if the ingress and egress were approved; it was also discussed about putting a light on 178th and Western because during mid-day with all the families coming in and out of the complex could produce a lot of traffic; it was also discussed that if a signal was installed perhaps Torrance would need to buy in. Another concern that was brought up was if the swimming pool and recreation area are large enough, and if there would be parking on the street; if a study could be done on implementing parking districts and possibly putting speed bumps on LaSalle; if garages could be converted to ADU's; the number of complaints the City received when Road Ex was occupying the space; the cost and size of the units; fire exits and the number of fire hydrants; the lighting throughout the complex; possibly adding a stripe and speed bumps on 178th. Acting Community Development Director Ray Barragan stated yes to the Environmental Impact Report and that the Fire Marshall approved the ingress/egress; that a traffic analysis was done and Sri Chakravarthy of Kimberly Horn & Associates gave additional information regarding the traffic study; Mr. Barragan stated that they have not looked into implement a parking district in that area; Mr. Brown indicated that some of the units would be 1500-1890 square feet and the price would range from \$550,000 to \$625,000 for 2, 3 and 4 bedroom units; he indicated that there would be 5 fire hydrants inside and 2 on each side of the street; that lighting would be throughout the parking lot, throughout lowlevel pedestrian ballards and light accentuating the landscape trees; he also proposed a 6-foot wall go between the complex and the mobile home park. Attorney Kranitz then added that if Council approved, we could add condition PW#16 that says Applicant shall stripe 178th between Western and Normandie.
