MINUTES Regular Meeting of the City of Gardena City Council Tuesday, September 8, 2020

The regular meeting of the City Council of the City of Gardena, California, was called to order at 7:00 p.m. on Tuesday, September 8, 2020, in the Council Chamber of City Hall, 1700 West 162nd Street, Gardena, California: Mayor Tasha Cerda presiding.

City Manager Osorio presented the Staff Report.

There was a discussion regarding the HUD requirements we have used in the past, and if we will continue to use them and how we are making this information available to business owners. City Manager Osorio explained we are relaxing some of the requirements to make it easier for people to qualify; we have increased the limit to \$30,000 and they have up until 6 months for commercial rental assistance. He continued to say that we will make the information available to our business owners through our Economic Development team; we have an email blast and we do direct outreach to them through all our social media outlets letting them know they are welcome to apply; so far 30 applications were received, and 16 awards have been granted.

Mr. Rudy Martinez, resident: spoke about getting the information out to the business owners by preparing a flyer in multiple languages to them as well.

Mr. Rudy Martinez, resident: He questioned where these cases were happening, and also asked about when the churches and parks will be opening up; he also asked if the City could get more information out to its residents.

Mayor Cerda stated that public health is our number one concern, we are doing the best we can in these trying times; we also plan and prepare as best as we can for our future. Mayor Pro Tem Henderson then stated that the actions we have taken as a City is because we are congruent with LA County Public Health. City Manager Osorio then stated that for LA County to relax some of the restrictions certain milestones and data have to be met; the infection and death rate has to go down, the City cannot act on anything because we do not have our own Public Health Director, we will always divert to LA County Public Health. He continued to say that because the City has an unincorporated area, the cases could be stemming from that area; but because of HIPPA laws, the County has not been able to delineate where the numbers are coming from.

(1) <u>COUNCIL MEMBER KASKANIAN</u>—He congratulated the officers, captains and sergeants who retired today. Captain Nico, Sergeant Gonsalves and Officer Evans. He thanked them for their service, he has known all three of them for many years and mentioned it was a pleasure working with them, they were a great asset to the city. He also asked Mayor Tasha Cerda to allow him to adjourn the meeting in the memory of his uncle Art Jarkian, who passed today in his sleep he was a long time Gardena business member.

- (2) COUNCIL MEMBER TANAKA— He gave his condolences to Council Member Kaskanian, and he hopes everyone had a great Labor Day. Since the last meeting he attended the first District 2 Zoom Meeting he stated it was a good meeting, he thinks this is going to be something new and good for all the District Lieutenants to start doing. He also attended the South Bay COG Board Meeting, and they had a special law enforcement program on Zoom and Mayor Butts from the City of Inglewood was the keynote speaker; he gave them some really good information. He also attended the South Bay COG membership meeting. He also congratulated all retirees, 90 years of knowledge. He mentioned Captain Niko was actually one of his trainees, Vince Osorio was one of his swat guys and Yvette was one of the people who pushed the radio car every day. He also attended the RCC Regional meeting and attended a couple promotions. He also wanted to remind everyone not to forget the 90th anniversary and to bring and donate the canned foods especially during these times and the food pantry really needs our support.
- (3) MAYOR PRO TEM HENDERSON- He gave his condolences to Council Member Kaskanian, he also congratulated the retirees for their 30 years of service and those that have been promoted to new positions. Since the last meeting, he attended the City of Gardena South Bay COG meeting and mentioned the COG is developing a group to determine some of the things that can be done in regard to leveraging fiber within the South Bay. He was also at the Community and Environmental Health Development Committee meeting and they talked about the LAUSD extension of their bond in regard to technology, he gave them some ideas in regard to crossing the digital divide for a lot of people in the community. He also stated that looking at the geography of our city facilities and schools, there's opportunities for funding and to start creating a wireless city. He also attended the COG's dialogue for Elected Officials, and they talked about Law Enforcement and Public Safety. The Police Department takes guidance from Elected Officials so as they put ideas out there and collaborate with the Chief. He then mentioned that at the SCAG meeting they talked about Connect SoCal as it is a plan related to jobs for underserved communities and that the new president of the SCAG organizations is Council Member Rex Richardson from City of Long Beach. He has created a race equity task force and he is a member of that task force they help homeless access resources. He also attended the Business Federation meeting, and they had a discussion of the COVID-19 task force regarding the LA County's move to have public health councils inspecting various businesses within LA County, the supervisors have not made a decision yet in regard to that, but the business community believes that could be a hindrance to their business and would like to propose better ideas like a grading system for business that are trying to meet the standards of being COVID clean. LA Bizfed will be reaching out to the 88 cities as well as the supervisors to see where we can get some clarity on what that means. A lot of our businesses have been negatively impacted and he believes we have to think of a way for them to operate. Lastly, he also participated in the voter registration event, voting is very important and wanted to remind everyone as Madam City Clerk stated is very important and want to make sure everyone participates and understand all the propositions on the ballot.
- (4) MAYOR CERDA She started off by congratulating those who got promoted, all that will be getting promoted on this coming Thursday and the retirees. She mentioned she once did a ride along with Sargent Gonsalves and saw what they go through on a day-to-day basis and what to expect; she is grateful to have been able to be a part of that especially during these times and thanks to all for their service. She then wanted to reiterate what the City Manager had mentioned earlier and invited everyone to attend the 90th anniversary celebration and to bring nine canned goods or items to receive a special

edition 90th anniversary mask. She mentioned that through good and bad at the end of the say we are all still here and she is very happy and excited to be able to celebrate 90 years. She attended a couple events through Zoom, the monthly CCGA meeting where she is the chairperson as it relates to our Casinos that group represents the cities in California, and she mentioned they are still fighting to see what they can do to reopen Casinos. She said it is interesting to hear what the Governor has said that all Casinos must be closed but then there's Native American Casinos that are not only open, but they have commercials, and their business are running as usual. She believes it is a little unfair, but they are doing what they can to maybe do some outdoor entertainment for our Casinos and they are reaching out to the Governor as it related to that. She also attended her monthly sanitation meeting and the third meeting she attended was through and organization called Surf and they help Autistic children and they just talked about some of the issues and concerns they have as it relates to COVID. She explained that they asked adults, and some are depressed, and they are feeling boxed in or not being able to go where they normally go and also the children that have learning disabilities and what it means for them, they questioned if they have been able to express it. She was very happy to have been able to join and had the opportunity to speak. Lastly, she mentioned the Food Giveaway happening on September 19th and that Council Member Herb Wesson from City of LA reached out to her and it is awesome he asked for the City of Gardena to partner up with them, she asked for everyone to share with their family and friends and anyone in need to spread the word.

(5) COUNCIL MEMBER FRANCIS – She first wanted to thank our City Clerk Mina Semenza and Deputy City Clerk Becky Romero for their awesome presentation and wanted to reiterate that we have a big election coming up on November 3rd and wants to make sure everyone comes out and votes, if anyone has any questions feel free to call the City Clerk's Office, she said the Office of the City Clerk works very hard to make sure we are covered especially on the North side of Gardena so she thanks them for hearing the concerns and for doing all that they can, a while back she attended the City Clerks Summit so she appreciates everything. She then wanted to thank everyone for their service, and she is sure it has not been easy, but she does appreciate what they have done for us and how well they have presented our City so again she thanked them. After, she mentioned she understands the frustration everyone feels because of COVID and she just wishes we all stay well, safe and healthy. We are all doing the very best we can and that there's always room for growth. Last time they met it was prior to Labor Day and just wanted to say the importance of workers in our country whether it is grocery workers, health care workers, teachers, or postal carriers we all need them because they are all putting their lives on the line as well.
