### **Bureau Requirements**

# **Eligible Controlled Games**







- or more players split a pot (that includes Poker Promotional Chips), and two or more of the players, but not all (Ex.-3 of the 4 players splitting) used a Poker Promotional Chip; the pot shall be split evenly with the Poker Promotional Chips going to the player with lamers and with odd chips going to the player closest to the dealer button.

If one of the three players who wagered with a Poker Promotional Chip wins, he or she shall receive the pot and the Poker Promotional Chip to be used again. 

Type of Game

The players of Big O High-Low Split play against each other for the "pot" of money on the table The game does not utilize a player-dealer position, it is a poker game. The gambling enterprise does not participate in the actual play of the game and has no interest in the outcome of the play.

Object of the Game

The object of the game is for players to form a five-card poker hand that ranks higher or lower than the other player's five-card poker hand. Each player must use two out of the five cards initially dealt to them at the beginning of the game, referred to as "hole" cards, and three out of the five cards dealt on the table throughout the course of the game, referred to as "community" cards to make their hand. When making a five-card low hand and a five-card high hand, a player is not required to use the same hole cards and/or community cards to complete each hand.

# Description of the Deck and Number of Decks Used

The game will be played using one standard 52-card deck and no joker. The cards will be machine shuffled, cut, and then dealt by the house dealer. If the automatic shuffling machine malfunctions, the cards shall be shuffled manually, cut, and dealt by the house dealer.

Card Values and Hand Rankings

Five-Card High Card Values- The rank of each card used in Big O High-Low Split when forming a five card high poker hand, in order of highest to lowest rank, will be: ace, king, queen, jack, 10, 9, 8, 7, 6, 5, 4, 3, and 2. All suits will be considered equal in rank. The ace would be considered low any time the ace begins a straight or a straight flush.

High hand ranking, from highest to lowest, is as follows:

Full House	A hand that consists of a Three of a Kind and a Pair. Three aces and two kings is the highest ranked Full House and three 2s and two 3s is the lowest ranked Full House.
Flush	A hand that consists of five cards of the same suit, but not in consecutive ranking. An ace, king, queen, jack, and 9 is the highest ranked Flush and a 7, 5, 4, 3, and 2 is the lowest ranked Flush.
Straight	A hand that consists of five cards in consecutive ranking, but not the same suit. An ace, king, queen, jack, and 10 is the highest ranked Straight and a 5, 4, 3, 2, and ace is the lowest ranked Straight.

Five-Card Low Card Values- The rank of each card used when forming a five-card low hand, in order of lowest to highest rank, will be: ace, 2, 3, 4, 5, 6, 7, and 8. All suits will be considered equal in rank.

Five-Card Low Hand Rankings- To make a qualifying five-card low hand, a player must have an 8 or lower, meaning the two hole cards used from the player's hand and the three community cards used by the player cannot contain a card with a value of 9 or higher.

- Additionally, when determining if a player has a qualifying five-card low hand, straights and flushes do not count against the player's hand if all other requirements are met. An ace is always considered low when determining a low hand.
- . If the player has a pair or higher in their low hand, the hand does not qualify.
- . The highest ranking possible five-card low hand is 5, 4, 3, 2, and ace; (called a Wheel).
- If multiple players have qualifying five-card low hands, the winning low hand is determined by comparing the highest card of each players' five-card hand, the lowest high card would be the winning hand.

For example, a hand of 7, 6, 4, 3, and ace is lower than a hand of 8, 6, 4, 3, and 2.

# Description of Table Used and Total Number of Seated Positions

The game will be played on a standard poker table and will accommodate up to eight seated positions for patrons. Each seated position at the table shall have the same minimum and maximum wagering limits during each betting round, as specified by the table limits.

# Dealing Procedures and Round of Play

- 1: The game shall utilize a flat white disk with the word "dealer" on it to visually designate which player is in the dealer position (in theory) for that hand.
  - a. The dealer button shall rotate from player to player around the table clockwise after each round of play.
  - b. The player with the dealer button is the last to receive cards when they are initially dealt at the beginning of the round of play and has the right of last action on all betting rounds (second, third, and fourth) except the first betting round, in which the big blind shall have the right to act last.
  - o When first opening a game, all players shall be dealt one card face-up, starting with the player to the immediate left of the house dealer and continuing clockwise around the table. The player with the highest ranked card shall receive the dealer button. If the ranking of the card is the same for two or more players, the player with the highest ranked card by suit (spades, hearts, diamonds, and clubs) shall receive the dealer button.
  - d. The cards shall then be collected by the house dealer and reshuffled.
- 2. On all subsequent betting rounds (second, third, and fourth), the action is started by the
  - a: The dealer, small blind, and big blind position shall rotate from player to player around the table clockwise after each round of play.

3. Once the dealer button has been distributed by the house dealer, the player to the Control immediate left of the player with the dealer button shall be the small blind position and shall be required to place the small blind. Additionally, the player to the immediate left of the player that is in the small blind position shall be in the big blind position and shall be required to place the big blind.

a. Both blinds are predetermined based on the posted table limit, mandatory for the players in the small blind and big blind positions, and are used to initiate action.

b. Both blind bets shall be placed in the center of the table, which is referred to as "the pot."

4. Once the blinds have been placed in the pot, the house dealer shall deal one card face-down to each player, starting with the player to the left of the dealer button, which is the player that is in the small blind position, and continuing clockwise around the table until all players have five cards face-down. These initial five cards are referred to as "hole cards."

5. Once each player has received their five hole cards, the first round of betting will occur.
Players are given the following options, starting with the player to the left of the player that is in the big blind position and continuing clockwise around the table:

a. Place a wager that is equal to the amount of the big blind, referred to as a "call"; or

b. Place a wager that is equal to the amount of the big blind as well as an additional amount within the posted table limit, referred to as a "raise." If a player raises the pot, all other players will have the option to call the raise, re-raise the pot by placing a wager larger than the raise within the posted table limit, or fold their hand. There is a maximum of three raises per round of betting, unless there are only two players participating during a round of betting, in which case there is no limit to the number of raises. When a raise or re-raise occurs, checking is not permitted; or

Place no additional wager at this time, referred to as a "check." This is only permitted for the player in the big blind position when all other players have called the big blind

and there have been no raises; or

d. Place their five hole cards face down into the center of the table, referred to as a fold. The hand shall be kept face down and shall be collected by the house dealer, who shall then place them in the discard pile. A player that chooses to fold their hand will no longer participate during that round of play.

After all players have acted in turn and either called all bets or folded their hand, the

house dealer shall move all player bets into the pot.

7. The house dealer shall then take the top card off the deck and place it in the discard pile without exposing it, referred to as a "burn card."

8. The house dealer shall then take the next three cards from the top of the deck and place them face-up on the table simultaneously, which is referred to as "the flop."

a. These are community cards and are available to all players.

- 9. Once the first three community cards have been placed face-up on the table, the second

a. This card shall also become a community card and is available to all players.

19. Once the fifth community card has been placed face-up on the table, which is the final community card, the fourth and final round of betting will occur-

20. All active players shall be given the following options, starting with the first active player to the left of the dealer button:

a. Place a wager according to the rules used in the previous round of betting; or

b. Call a bet or raise according to the rules used in the previous round of betting; or

c. Raise the pot according to the rules used in the previous round of betting; or

d. Check, with the option to call or raise a wager by another player; or

e. Fold their hand according to the rules used in the previous round of betting.

21. After the fourth round of betting is complete, the house dealer shall move all player bets into the pot.

22. All active players will then enter into a showdown with one another and compare their nands.


# How Winners are Determined and Paid

Players must use two of the five hole cards initially dealt to them at the beginning of the game and three of the five community cards turned over throughout the round of play to make the highest ranking and lowest ranking five-card poker hand. The following will apply for determining the player(s) who wins the pot:

If there is no qualifying five-card low hand as described in the hand rankings chart above, the entire pot will be awarded to the player with the highest ranked five-card high hand. All other players will lose.

If there is one qualifying five-card low hand, the pot will be split equally in half, with half the pot being awarded to the player with the highest-ranked five-card hand and the other half of the pot being awarded to the player with the lowest ranked five-card hand.

If more than one player has the highest ranked five-card high hand and there is no qualifying five-card low hand, the entire pot shall be split equally among all players with the highest ranking five-card hand.

If more than one player has the highest ranking five-card hand and there is a qualifying five-card low hand, the pot shall be divided in half, with half the pot being split among all players with the highest ranking five-card hand, and the other half of the pot being awarded to the player with the lowest ranking five-card hand.


If more than one player has the lowest ranking five-card hand and one player has the highest ranking five-card hand, the pot shall be divided in half, with half the pot being split. among all players with the lowest ranking five-card hand, and the other half of the pot being awarded to the player with the highest ranking five-card hand.

If more than one player has the highest ranking five-card hand and more than one player has the lowest ranking five-card hand, the pot shall be divided in half, with half the pot being split equally among all players with the highest ranking five-card hand, and the other half of the pot being split equally among all players with the lowest ranking five-card hand.

Furthermore, a player is eligible to win both the high hand portion of the pot as well as the low hand portion of the pot if they have the highest ranked five-card poker hand and the lowest qualifying five-card poker hand.

In the instance that there are an odd number of chips, the odd chips will be awarded to the player immediately clockwise of the dealer button.



The Bureau of Gambling Control (Bureau) has reviewed Larry Flynt's Lucky Lady Casino's request to offer the game of Big O High-Low Split for play. This letter is to inform you that the Bureau has approved this request, and Larry Flynt's Lucky Lady Casino may begin offering the game for play, as enclosed, pending any approvals that may be required by the local jurisdiction. This letter of approval and the enclosed rules shall be kept on file, at Larry Flynt's Lucky Lady Casino, and be readily available for review during all hours of operation. Any changes to the approved rules of play shall constitute a new game and invalidate this approval.

The Bureau reserves the right to: (1) review the lawfulness of the game of Big O High-Low Split; (2) notify all law enforcement agencies and gambling establishments if further review determines the game of Big O High-Low Split to be unlawful; (3) require gambling establishments to cease and desist offering the game of Big O High-Low Split if found to be unlawful; and (4) take action against those gambling establishments that decline to abide by the Bureau's cease and desist notification.

Larry Flynt's Lucky Lady Casino shall play the game of Big O High-Low Split in accordance with the Bureau approved rules, as enclosed.

Although the Bureau has approved the game of Big O High-Low Split, it is the sole responsibility of Larry Flynt's Lucky Lady Casino to abide by and remain in compliance with the local ordinance for the City of Gardena. This letter does not constitute any approvals that may be required by the local jurisdiction before the game of Big O High-Low Split is offered for play. Larry Flynt's Eucky Lady Casino shall be fully responsible for ensuring any approval required by local law enforcement is obtained prior to offering the game of Big O High-Low Split for play.

California Code of Regulations, title 11, section 2070, subdivision (b), states:

It shall be an unsuitable method of operation for a gambling establishment to:

Therefore, any changes Larry Flynt's Lucky Lady Casino may wish to make in the future to the approved game, as enclosed, shall be submitted to the Bureau along with the required fees, and will not be authorized until written notification of approval from the Bureau is received.

Type of Game

The players of Big O High-Low Split play against each other for the "pot" of money on the table. The game does not utilize a player-dealer position, it is a poker game. The gambling enterprise. does not participate in the actual play of the game and has no interest in the outcome of the play ...

Object of the Game

The object of the game is for players to form a five-card poker hand that ranks higher or lower than the other player's five-card poker hand. Each player must use two out of the five cards initially dealt to them at the beginning of the game, referred to as "hole" cards, and three out of the five cards dealt on the table throughout the course of the game, referred to as "community" cards to make their hand. When making a five-card low hand and a five-card high hand, a player is not required to use the same hole cards and/or community cards to complete each hand:

Description of the Deck and Number of Decks Used

The game will be played using one standard 52-card deck and no joker. The cards will be machine shuffled, cut, and then dealt by the house dealer. If the automatic shuffling machine malfunctions, the cards shall be shuffled manually, cut, and dealt by the house dealer.

Card Values and Hand Rankings

Five-Card High Card Values- The rank of each card used in Big O High-Low Split when forming a five-card high poker hand, in order of highest to lowest rank, will be: ace, king, queen, jack, 10, 9, 8, 7, 6, 5, 4, 3, and 2. All suits will be considered equal in rank. The ace would be considered low any time the ace begins a straight or a straight flush.

High hand ranking, from highest to lowest, is as follows:

Four of a Kind	A hand that consists of four cards of the same rank. Four aces is the highest ranked Four of a Kind and four 2s is the lowest ranked Four of a Kind.
Full House	A hand that consists of a Three of a Kind and a Pair. Three aces and two kings is the highest ranked Full House and three 2s and two 3s is the lowest ranked Full House.
Flush	A hand that consists of five cards of the same suit, but not in consecutive ranking. An ace, king, queen, jack, and 9 is the highest ranked Flush and a 7, 5, 4, 3, and 2 is the lowest ranked Flush.
Straight	A hand that consists of five cards in consecutive ranking, but not the same suit. An ace, king, queen, jack, and 10 is the highest ranked Straight and a 5, 4, 3, 2, and ace is the lowest ranked Straight.
Three of a Kind	A hand that consists of three cards of the same rank. Three aces is the highest ranked Three of a Kind and three 2s is the lowest ranked Three of a Kind.
Two Pair	A hand that consists of two Pairs. Two aces and two kings is the highest ranked Two Pair and two 3s and two 2s is the lowest ranked Two Pair.

Five-Card Low Card Values-. The rank of each card used when forming a five-card low hand, in order of lowest to highest rank, will be ace, 2, 3, 4, 5, 6, 7, and 8. All suits will be considered equal in rank.

Five-Card Low Hand Rankings- To make a qualifying five-card low hand, a player must have an 8 or lower, meaning the two hole cards used from the player's hand and the three community cards used by the player cannot contain a card with a value of 9 or higher.

- Additionally, when determining if a player has a qualifying five-card low hand, straights and flushes do not count against the player's hand if all other requirements are met. An ace is always considered low when determining a low hand.
- If the player has a pair or higher in their low hand, the hand does not qualify.
- . The highest ranking possible five-card low hand is 5, 4, 3, 2, and ace; (called a Wheel).
- If multiple players have qualifying five-card low hands, the winning low hand is determined by comparing the highest card of each players' five-card hand, the lowest high card would be the winning hand.


For example, a hand of 7, 6, 4, 3, and ace is lower than a hand of 8, 6, 4, 3, and 2.

# Description of Table Used and Total Number of Seated Positions

The game will be played on a standard poker table and will accommodate up to eight seated positions for patrons. Each seated position at the table shall have the same minimum and maximum wagering limits during each betting round, as specified by the table limits.

# Dealing Procedures and Round of Play

- The game shall utilize a flat white disk with the word "dealer" on it to visually designate which player is in the dealer position (in theory) for that hand.
  - a. The dealer button shall rotate from player to player around the table clockwise after each round of play.
  - b. The player with the dealer button is the last to receive cards when they are initially dealt at the beginning of the round of play and has the right of last action on all betting rounds (second, third, and fourth) except the first betting round, in which the "big blind" shall have the right to act last.
  - c. When first opening a game, all players shall be dealt one card face-up, starting with the player to the immediate left of the house dealer and continuing clockwise around the table. The player with the highest ranked card shall receive the dealer button. If the ranking of the card is the same for two or more players, the player with the highest ranked card by suit (spades, hearts, diamonds, and clubs) shall receive the idealer button.
  - d. The cards shall then be collected by the house dealer and reshuffled.
- 2 On all subsequent betting rounds (second, third, and fourth), the action is started by the first active player to the left of the dealer button.
  - a. The dealer, small blind, and big blind position shall rotate from player to player around the table clockwise after each round of play.



Once the dealer button has been distributed by the house dealer, the player to the immediate left of the player with the dealer button shall be the small blind position and trol shall be required to place the small blind. Additionally, the player to the immediate left of the player that is in the small blind position shall be in the big blind position and shall be required to place the big blind.

a. Both blinds are predetermined based on the posted table limit, mandatory for the players in the small blind and big blind positions, and are used to initiate action.

- b. Both blind bets shall be placed in the center of the table, which is referred to as "the ·pot."
- Once the blinds have been placed in the pot, the house dealer shall deal one card facedown to each player, starting with the player to the left of the dealer button, which is the player that is in the small blind position, and continuing clockwise around the table until all players have five cards face-down. These initial five cards are referred to as "hole
- Once each player has received their five hole cards, the first round of betting will occur. Players are given the following options, starting with the player to the left of the player that is in the big blind position and continuing clockwise around the table:
  - a. Place a wager that is equal to the amount of the big blind, referred to as a "call", or
  - b. Place a wager that is equal to the amount of the big blind as well as an additional amount within the posted table limit, referred to as a "raise." If a player raises the pot all other players will have the option to call the raise, re-raise the pot by placing a wager larger than the raise within the posted table limit, or fold their hand. There is a maximum of three raises per round of betting, unless there are only two players participating during a round of betting, in which case there is no limit to the number of raises. When a raise or re-raise occurs, checking is not permitted; or
  - c. Place no additional wager at this time, referred to as a "check." This is only permitted for the player in the big blind position when all other players have called the big blind and there have been no raises; or
  - d. Place their five hole cards face down into the center of the table, referred to as a \*fold." The hand shall be kept face-down and shall be collected by the house dealer, who shall then place them in the discard pile. A player that chooses to fold their hand will no longer participate during that round of play.
- After all players have acted in turn and either called all bets or folded their hand, the house dealer shall move all player bets into the pot.
- The house dealer shall then take the top card off the deck and place it in the discard pile without exposing it, referred to as a "burn card."
- The house dealer shall then take the next three cards from the top of the deck and place them face-up on the table simultaneously, which is referred to as "the flop."
  - a. These are community cards and are available to all players.
- Once the first three community cards have been placed face-up on the table, the second round of betting will occur.
- 10. All active players, which are players that called all wagers and did not fold their hand. shall be given the following options, starting with the first active player to the left of the
  - Place a wager according to the rules used in the previous round of betting; or
  - Call a bet or raise according to the rules used in the previous round of betting; or
  - Raise the pot according to the rules used in the previous round of betting; or
  - Check, with the option to call or raise a wager by another player; or
  - Fold their hand according to the rules used in the previous round of betting.
- After all players have acted in turn and either called all bets or folded their hand, the house dealer shall move all player bets into the pot.

12. The house dealer shall then burn a card.

13. The house dealer shall then take one card from the top of the deck and place it face-up on the table so that there are now a total of four community cards face-up on the table, which is referred to as the "turn.".

a. This card shall also become a community card and is available to all players.

14. Once the fourth community card has been placed face-up on the table, the third round of betting will occur.,

15. All active players shall be given the following options, starting with the first active player to the left of the dealer button:

a. Place a wager according to the rules used in the previous round of betting; or .

- b. Call a bet or raise according to the rules used in the previous round of betting; or
- c. Raise the pot according to the rules used in the previous round of betting, or

d. Check, with the option to call or raise a wager by another player; or

e. Fold their hand according to the rules used in the previous round of betting.

16. After all players have acted in turn and either called all bets or folded their hand, the house dealer shall move all player bets into the pot.

17. The house dealer shall then burn a card.

18. The house dealer shall then take one card from the top of the deck and place it face-up on the table so that there are now a total of five community cards face-up on the table. This is referred to as the "river card."

a. This card shall also become a community card and is available to all players.

- 19. Once the fifth community card has been placed face-up on the table, which is the final community card, the fourth and final round of betting will occur.
- 20. All active players shall be given the following options, starting with the first active player to the left of the dealer button:
  - a. Place a wager according to the rules used in the previous round of betting; or
  - b. Call a bet or raise according to the rules used in the previous round of betting; of
  - c. Raise the pot according to the rules used in the previous round of betting; or
  - d. Check, with the option to call or raise a wager by another player; or

e. Fold their hand according to the rules used in the previous round of betting.

- 21 After the fourth round of betting is complete, the house dealer shall move all player bets into the pot.
- 22, All active players will then enter into a showdown with one another and compare their nands.
  - a. If there is only one active player left in the game, the pot will be awarded to the active player and a new round will begin.

### How Winners are Determined and Paid

Players must use two of the five hole cards initially dealt to them at the beginning of the game and three of the five community cards turned over throughout the round of play to make the highest ranking and lowest ranking five-card poker hand. The following will apply for determining the player(s) who wins the pot: -

- If there is no qualifying five-card low hand as described in the hand rankings chart above, the entire pot will be awarded to the player with the highest ranked five-card high hand. All other players will lose.
- If there is one qualifying five-card low hand, the pot will be split equally in half, with half the pot being awarded to the player with the highest-ranked five-card hand and the other half of the pot being awarded to the player with the lowest ranked five-card hand.

If more than one player has the highest ranked five-card high hand and there is no control qualifying five-card low hand, the entire pot shall be split equally among all players with the highest ranking five-card hand.

if more than one player has the highest ranking five-card hand and there is a qualifying five-card low hand, the pot shall be divided in half, with half the pot being split among all players with the highest ranking five-card hand, and the other half of the pot being awarded

to the player with the lowest ranking five-card hand.

• If more than one player has the lowest ranking five-card hand and one player has the highest ranking five-card hand, the pot shall be divided in half, with half the pot being split among all players with the lowest ranking five-card hand, and the other half of the pot being awarded to the player with the highest ranking five-card hand.

of If more than one player has the highest ranking five-card hand and more than one player has the lowest ranking five-card hand, the pot shall be divided in half, with half the pot being split equally among all players with the highest ranking five-card hand, and the other half of the pot being split equally among all players with the lowest ranking five-card hand.

• Furthermore, a player is eligible to win both the high hand portion of the pot as well as the low hand portion of the pot if they have the highest ranked five-card poker hand and the

lowest qualifying five-card poker hand.

o They do not have to use the same cards (hole and community) to win both pots. In the instance that there are an odd number of chips, the odd chips will be awarded to the

player immediately clockwise of the dealer button.

- The collection fees shall be predetermined and conspicuously posted on each table prior to any cards being dealt or a round of play commencing.
- Collection rates and fees shall be determined prior to the start of play of any hand or round.
- Only one collection schedule option, which utilizes one table limit and the specified collection fees for that table limit, as listed above, shall be used at a table at any one
- Rates may not be calculated as a fraction or percentage of wagers made or winnings earned.
- Flat fees on wagers may be assessed at different collection rates; however, no more than five collection rates may be established per table limit.
- Larry Flynt's Lucky Lady Casino shall provide ample notice to patrons regarding the collection rates and fees, as well as the procedure for collecting them.

In the name of the members of St. Anthony of Padua Catholic Church, I present for your consideration a request to schedule our 83<sup>rd</sup> annual Strawberry Park Days Fiesta on the parish grounds from Friday through Sunday, May 17, 18 & 19, 2019. The hours will be Friday 6 pm to 11 pm, Saturday noon to 11 pm and Sunday noon to 11:30 pm.

As in previous years, we request permission to close 163<sup>rd</sup> St. (between Berendo Ave. and New Hampshire Ave.) and 162<sup>nd</sup> St. (between Budlong Ave. and Berendo Ave.). In addition, we are requesting the closing of Berendo Ave. (between 162<sup>nd</sup> St. and 163<sup>rd</sup> St.) and New Hampshire (between 163<sup>rd</sup> St. and 164<sup>th</sup> St.). - The Applicant shall contact the Los Angeles County Fire Department at (310) 263-2732 prior to the
  event to schedule an inspection and complete all necessary forms. A fire safety inspection shall be
  conducted and approval of the inspection is required prior to the start of the carnival;
- 2. The Applicant shall contact the City of Gardena Community Development Department at (310) 217-9530, 48 hours prior to the event to schedule an inspection after the site is set-up, but prior to the commencement of any activities. Please note that any electrical work, with the exception of plug-in, will require an electrical permit obtained by a licensed electrical contractor;
- 3. The Applicant shall have all fire and building safety inspections conducted and approval prior to the start of the carnival;



#### RECOMMENDATION AND STAFF SUMMARY:

Staff respectfully recommends that City Council approve the payment for the Police Department Carport Re-roofing project to Midwest Roofing Co., Inc. in the amount of \$30,528.

The scope of work consisted of clearing all roofing, debris, and hauling it away; inspecting the deck and replacing rotted wood, as needed; sealing all pipes and vents; and obtaining a building permit.

The roof needed an emergency repair. Therefore, this purchase was made following Gardena Municipal Code § 2.60.170 which specifies that, in the event of an emergency, the provision of services and purchases can be made by the most advantageous method available.

### City of Gardena Consolidated Street Lighting District FY 2019-2020

#### **DEFINITION & GENERAL INFORMATION**

#### **Assessment District**

An Assessment District is a financing mechanism under The California Streets and Highways Code, Division 10 and 12, which enables cities, counties, and special districts organized for the purpose of aiding in the development or improvement to, or within the district, to designate specific areas as Assessment Districts, with the approval of a majority of the landowners based on financial obligations, and allows these Districts to collect funds to finance maintenance efforts or construct improvements. Assessment Districts help each property owner pay a fair share of the costs of such improvements or maintenance obligations over a period of years at reasonable rates and insures that the cost will be spread to all properties that receive direct and special benefit by the improvements constructed or maintained. "Assessment" means any levy or charge by an agency upon real property that is based upon the special benefit conferred upon the real property by a public improvement or service that is imposed to pay the capital cost of the public improvement, the maintenance and operation expenses of the public improvement, or the cost of the service being provided. "Assessment" includes, but is not limited to, "Special Assessment," "Benefit Assessment," and "Maintenance Assessment."

#### **Current Annual Administration**

As required by the Landscaping and Lighting Act of 1972, this Engineer's Report describes the improvements to be operated, maintained, and serviced by the District, provides an estimated budget for the District, describes the properties and zones of benefit within the District, describes the method used to allocate the costs to the benefiting properties within the District, and lists the proposed assessments to be levied upon each assessable lot or parcel within the District.

Plans and specifications for the improvements provided by the District are on file in the office of the Public Works Engineering Division and are incorporated into this report by reference. The plans and specifications detail the location, class and type of each existing street lighting fixture. The fixtures are delineated on a plan of the City and the site of each fixture is detailed indicating attributes of the fixture. The attributes include the intensity of the lamp and type of light. A summary is also incorporated listing the number and totals for each type of luminaries.

Payment of the assessment is placed on each property owner's secured property tax roll bill. All funds collected through the assessment must be placed in a special fund and can only be used for the purposes stated in this report.

# ENGINEER'S REPORT PREPARED PURSUANT TO THE PROVISIONS OF THE LANDSCAPING AND LIGHTING ACT OF 1972 SECTION 22500 THROUGH 22679 OF THE CALIFORNIA STREETS AND HIGHWAYS CODE

Pursuant to Part 2 of Division 15 of the Streets and Highways Code of the State of California, and in accordance with the Resolution of Initiation adopted by the Council of the City of Gardena, County of Los Angles, State of California, in connection with the proceedings for:

### CITY OF GARDENA CONSOLIDATED STREET LIGHTING ASSESSMENT DISTRICT

Herein after referred to as the "Assessment District" or "District", I, Joseph Cruz, P.E., the duly appointed ENGINEER OF WORK, submit herewith the "Report" consisting of six (6) parts as follows:

#### PART A: DESCRIPTION OF IMPROVEMENTS

Part A describes the improvements in the District. Plans and specifications for the improvements showing and describing the general nature, location, and extent of the improvements are on file in the Office of the City Clerk of the City of Gardena; and are incorporated herein by reference.

#### **PART B: ESTIMATE OF COST**

Part B contains an estimate of the cost of the proposed improvements for FY 2019-2020, including incidental costs and expenses in connection therewith.

#### PART C: ASSESSMENT DISTRICT DIAGRAM

The Diagram of the Assessment District Boundaries showing the exterior boundaries of the Assessment District, the boundaries of any zones within the Assessment District, and the lines and dimensions of each lot or parcel of land within the Assessment District.

The lines and dimensions of each lot or parcel within the Assessment District are those lines and dimensions shown on the maps of the Assessor of the County of Los Angeles for the year when this Report was prepared. The Assessor's maps and records are incorporated by reference herein and made part of this Report.

#### PART D: METHOD OF APPORTIONMENT OF ASSESSMENTS

The method of apportionment of assessments, indicating the proposed assessment of the total amount of the costs and expenses of the improvements upon the several lots and parcels of land within the Assessment District, in proportion to the estimated benefits to be received by such lots and parcels.

#### PART E: PROPERTY OWNER LIST & ASSESSMENT ROLL.

Part E includes a list of the names and addresses of the owners of real property within the Assessment District, as shown on the last equalized roll of the Assessor of the County of Los Angeles are included in Part E. The list is keyed to the records of the County Assessor of the County of Los Angeles, which are incorporated herein by reference.

#### PART F: FINANCIAL STUDY AND PROPOSED RATE INCREASE

Part F includes the Financial Study performed for fiscal year 2019-2020 of the base year. This section includes detailed information regarding the proposed rate increase for the District for the fiscal year and provides estimates for future years.

#### PART A

#### **DESCRIPTION OF IMPROVEMENTS**

The facilities, which have been constructed within the boundaries of the City of Gardena District, and those which may be subsequently constructed, will be operated, maintained and serviced as generally described as follows:

DESCRIPTION OF IMPROVEMENTS FISCAL YEAR 2019-2020

### CITY OF GARDENA CONSOLIDATED STREET LIGHTING ASSESSMENT DISTRICT

The facilities to be maintained and serviced include an annexed area called the West Gardena area in 1995. The costs for the street lighting were paid through the County of Los Angeles by an ad valorem tax and assessment. The lighting costs were transferred to the City of Gardena in 1997 after the removal of the County Lighting District and Assessment District. The ad valorem tax charge of the County for lighting was also transferred to the City of Gardena to fund the lighting costs in this area in 1997. The plans for lighting reflect the addition of the new lighting.

The plans and specifications for the improvements, showing and describing the general nature, location and the extent of the improvements, are on file in the office of Public Works, and are incorporated herein by reference.

#### PART B

#### **ESTIMATE OF COST**

The 1972 Act provides that the total cost of installation, construction, operation, maintenance and servicing of the improvements described in Part A can be recovered by the District. Maintenance can include the repair and replacement of existing facilities. Servicing can include electrical and associated costs from a public utility. Incidental expenses, including administration of the District, engineering fees, legal fees, printing, posting and mailing of notices, and all other costs associated with the annual assessment process can also be included.

The estimated costs of the operation, servicing and maintenance of the improvements for Fiscal Year 2019-2020, as described in Part A, are summarized herein, and described in the Proposed Budgets on the subsequent pages.

The significant increases in energy costs experienced in early 2001 are expected to continue through 2019-2020. The City had anticipated increases in energy costs for several years and had set aside reserves to pay for the increases. However, the depletion of this reserve has warranted an increase in assessments.

The City of Gardena, in 2009-2010 fiscal year increased the assessment by conducting an assessment ballot (Proposition 218) proceeding by mailed ballots for approval of the increase, in accordance with Section 53753 of the Government Code and Section 4000 of the Election's Code.

The increase in assessments in the FY2009-2010 did not allow the District to wipe out its negative reserve in the 2010-2011 and 2011-2012 fiscal years; however, for 2012-2013 fiscal year, with 2.09% increase, the reserve started a modest gain; and for 2019-2020 fiscal year, with projected 3.2% increase the District is also projected to build up reserves in the positive.

The 1972 Act requires that a special fund be set up for the revenues and expenditures of the District. Funds raised by assessment shall be used only for the purpose as stated herein. Any balance or deficit remaining on July 1 must be carried over to the next fiscal year.

#### PART D

#### METHOD OF APPORTIONMENT OF ASSESSMENT

#### GENERAL

Part 2 of Division 15 of the Streets and Highways Code, the Landscaping and Lighting Act of 1972, permits the establishment of assessment districts by public agencies for the purpose of providing certain public improvements, which include operation, maintenance and servicing of street lights, traffic signals, and landscaping.

Section 22573 of the Landscape and Lighting Act of 1972 requires that maintenance assessments be levied according to benefit rather than according to assessed value. This Section States:

"The net amount to be assessed upon lands within an assessment district may be apportioned by any formula or method which fairly distributes the net amount among all assessable lots or parcels in proportion to the estimated benefit to be received by each such lot or parcel from the improvements."

In addition, Article XIIID, Section 4(a) of the California Constitution limits the amount of any assessment to the proportional special benefit conferred on the property.

The Act permits the designation of benefit zones within any individual assessment district if "by reasons or variations in the nature, location, and extent of the improvements, the various areas will receive different degrees of benefit from the improvement" (Sec. 22574). Thus, the 1972 Act requires the levy of a true "benefit assessment" rather than a "special tax."

#### ASSESSMENT METHODOLOGY

The total operation, maintenance, and servicing costs for the assessment district improvements are apportioned in accordance with the benefit spread described below.

#### General versus Special Benefit

The assessment cost for each parcel is determined by the front linear footage of the property, multiplied by the applicable rate for that parcel. If the property faces more than one street or alley, the cost is determined by the linear footage of the longest side facing a street/alley plus 10 percent of the rest of the sides facing a street/alley, multiplied by the rate. Rate of assessment is determined by zone. The rates are determined by the quantity of street lighting in each zone, spacing frequency being most intense in commercial zone and least intense in residential zones and near public properties. This method of apportionment ensures that properties are not assessed in excess of the proportional special benefit conferred.

#### PART E

#### PROPERTY OWNER LIST & ASSESSMENT ROLL

The total proposed assessment for Fiscal Year 2019-2020 and the amount of proposed assessment apportioned to each lot or parcel within the District, as shown on the latest roll at the County of Los Angeles Assessor's Office, are contained in the Assessment Rolls and the description of each lot or parcel is part of the records of the Assessor of the County of Los Angeles and these records are, by reference, made part of this Report.

The included tracts of land have been subdivided into four zones, with each of subject lots benefiting from the improvements being maintained. Therefore, the costs associated with the street lighting within and directly adjacent to each tract, as shown in Part B of this report will be apportioned to pay in accordance with the property frontage within each zone.

#### PART F

#### FINANCIAL STUDY

Staff has performed a financial study of the District for the 2019-2020 FY to ensure that the maintenance and improvement costs for the district were funded appropriately.

In FY 2009-2010, through Prop. 218, the City of Gardena approved increased assessments for the District as indicated in the summary below. Additionally, the study recommended adjustment of future annual assessments as needed, per the Consumer Price Index (CPI), All Urban Consumers, for the Los Angeles, Long Beach, and Anaheim Areas, not to exceed 50% of operating reserves. The actual assessments levied in any fiscal year will be approved by the City Council. Please see "Appendix A" for a copy of the detailed Financial Study for the District.

Since the increase in the assessments was approved, benefit areas within the District will continue to be maintained at the highest service levels. The proposed increase includes language to adjust assessments per the CPI, future votes regarding this annual increase will not be needed; however, each year staff will present the annual Engineer's Reports with the recommended assessment amount. For FY 2019-2020, an increase of 3.2% is recommended.

#### OPERATING EXPENDITURES

The following information describes the types of costs associated with maintaining the District, as well as information regarding the proposed rate increase. The financial study projects the expenditures and revenues through Fiscal Year 2019/2020.

#### CPI – Annual Increase According to Need

In FY 2009-2010, the City approved a recommended scaled increase in assessments to occur over a two year period for the District. After the initial scaled increase, the assessments are increased annually per the CPI on an as needed basis (3.2% per year for the study). Should the district reach a reserve level not-to-exceed 50% of operating revenues, the assessment will not be increased per the CPI for the year. Each year, the City will evaluate the reserves and the expenditures, and inform the residents whether or not an increase per the CPI will be necessary for the upcoming year.

#### Maintenance Upgrades/Projects

The line item in the proposed budget and financial study for Maintenance Upgrades/Projects includes any new projects such as new conduits, wiring, lights, or poles, etc. that can be scheduled for the upcoming year. Often, City staff receives input from residents on any projects that a district may like to see completed. The proposed budget includes an estimate for these projects, and if the amount actually spent each year is less than the estimate, the remaining balance returns to the District's reserve fund. Should the amount exceed the estimate, then the funds needed would be taken from the reserve fund.


#### Reserve Fund

Any remaining funds not used from the previous year are added to the District's reserve fund. The reserve fund should have sufficient funds available to lessen the fiscal impact of any unforeseen expenditures. Staff is recommending that the district maintain a healthy reserve balance of an amount not-to-exceed 50% of the total annual assessments.

WHEREAS, the City of Gardena, California, previously established the Gardena Artesia Boulevard Landscaping Assessment District; and

WHEREAS, on March 12, 2019, the City Council of the City of Gardena, California, adopted Resolution No. 6358 ordering the General Services Director to prepare and file a report according to the provisions of the "Landscaping and Lighting Act of 1972" of the State of California Streets and Highways Code, Division 15, Part 2, for assessments to be levied upon and collected through the Gardena Artesia Boulevard Landscaping Assessment District for fiscal year 2019-2020; and

WHEREAS, the Engineer's Report bearing the date of April 23, 2019, was prepared and was filed in the office of the City Clerk; and

WHEREAS, the City Clerk has presented the Engineer's Report to the City Council, and said Council has examined and considered the Engineer's Report and is satisfied with all the items contained in Engineer's Report; and

WHEREAS, the City Council of the City of Gardena, California, proposes to levy and collect annual assessments according to the "Landscaping and Lighting Act of 1972" of the State of California Streets and Highways Code, Division 15, Part 2, for Fiscal Year 2019-2020;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GARDENA, CALIFORNIA, DOES HEREBY RESOLVE, AS FOLLOWS:

SECTION 1. That the Engineer's Report bearing the date of April 23, 2019, was prepared and filed with the City Clerk in conformity with the provisions of the State of California Streets and Highways Code, Division 15, Part 2, Landscaping and Lighting Act of 1972. The Engineer's Report contains the plans and specifications for the maintenance of the improvements, an estimate of the costs of the maintenance and servicing, a diagram for the assessment district and an assessment of the estimated costs of the maintenance and servicing of the improvements.

SECTION 2. The City Council approves the Engineer's Report as filed and sets a public hearing for Tuesday, May 28, 2019, at 7:30 p.m., in the Gardena City Council Chambers, 1700 West 162nd Street, in the City of Gardena, California, to consider the levy and collection of the assessment for the Gardena Artesia Boulevard Landscaping Assessment District for Fiscal Year 2019-2020.

SECTION 3. The City Clerk or designee is authorized and directed to give notice of the hearing in time, form, and manner as required by the California Streets and Highways Code, Division 15, Part 2, Landscaping and Lighting Act of 1972.

SECTION 4. That the City Council declares its intention to levy upon and collect assessments at the same rate as previously established through the Gardena Artesia Boulevard Landscaping Assessment District for Fiscal Year 2019-2020, except that no assessments shall be imposed upon property owned by the state or federal government or any local agency.

SECTION 5. That the boundaries of the Gardena Artesia Boulevard Landscaping Assessment District are as shown and described in the attached map and incorporated by reference.
