C. CITY MANAGER REMARKS RE: DIRECTIVES / COUNCIL ITEMS

City Manager Medrano gave a verbal report of information to follow-up matters that had been directed or requested by the Mayor and Members of Council. Written reports had already been provided to the Council via copies in their regular mail packets. Those items are, as follows:

Chief Kang thanked everyone for their support.

D. COUNCIL REMARKS

(1) COUNCIL MEMBER HENDERSON – since the last Council Meeting, he attended the LA Voter Center presentation that was conducted by the LA County Registrar's office. He mentioned he was there with Deputy City Clerk, Becky Romero. While there he proposed some of the old voting location for new voting centers. He said it was a great presentation on the new voting machines and they were open to coming to do a presentation to our community as well. He reported that he had the humbling honor to be the keynote speaker at the University of La Verne's African American graduation ceremony. It meant a lot to him as a former student at that University. He said he was at the Don Dear Roast for only a brief time. He shook Don Dear's hand and congratulated him. He mentioned he had a meeting with the few labor representatives where they spoke about project labor agreements and different issues with where Gardena stands. He attended an event called "Snacks with Clergy" where they spoke about the spirituality and morality of our community. He attended a Centinela Youth Services Committee Meeting in Lawndale, CA, explaining that Centinela Youth Services works with juveniles who are offenders to help them remediate the process. On Sunday, he attended the Gardena Nisei Memorial event at which his esteemed colleague, Councilman Emeritus Ronald Ikejiri was the keynote speaker. He acknowledged those who paid the ultimate sacrifice while serving in the military; that we stand on their shoulders: and freedom comes at a cost. He wanted to make sure that we acknowledge them.

He apologized for missing the Medal of Valor ceremony due to having to attend his grandchildren's graduation. He attended the Nisei VFW Memorial Day event, and said he brought up the difference between Veterans Day, Memorial Day and Armed Forces Day. He attended the memorial services with Maxine Waters and said it was good to memorialize those who paid the ultimate price. He said he got some donations from New Challenge Ministries and delivered over \$500 worth of Ben and Jerry's ice cream and World's Finest Chocolates to the Boys and Girls Club of Harbor Gateway and the recipients were ecstatic.
 - (3) MAYOR PRO TEM KASKANIAN since the last Council Meeting, on May 8, he attended the City Clerk's Week Celebration. On May 16, he went to Fresno to attend an Elks Lodge convention. On May 22, he attended the Public Works Week event and congratulated Joe Cruz. On May 23, he attended the Medal of Valor Ceremony and congratulated Officers Jose Avalos and Angel Hernandez. He offered a Happy belated Memorial Day and thanked all men and women in uniform. He said that, without them, we wouldn't be here today. He then shared that May 28 is celebrated as Armenian's Independence Day.
 - (4) MAYOR CERDA since the last Council Meeting, she attended the monthly California Cities for Self-Reliance JPA Meeting, where they are working to make sure their casinos are operating properly and making sure that their cities (including Gardena) gets a portion of the revenue. She attended the MTA Southwest Sector LA County City Selection meeting in the City of Torrance where they nominated and appointed City of Inglewood Mayor Butts to the Metropolitan Transportation Authority for a 4-year term. She attended a County Sanitation District meeting in Torrance on May 15. Later that day, she spoke at a local Gardena church regarding ways that they can be more involved in the City of Gardena. On the next day, she attended the One Life to Live event hosted by G-DAAP Task Force. She thanked the students for doing a great job to make people aware of these different things out there and for being ambassadors and telling their friends not to vape and use other sorts of drugs. On the next day, she attended the grand opening of Giant Step Store and More, located on 135th and Crenshaw Blvd. She shared that it's a neighborhood store that employs and works with developmentally disabled youth and they also have a second-hand store in the back. She welcomed them to Gardena said they will be a great asset to our community. She reported that she was a keynote speaker for an organization called Links. She shared that it's an organization which consists of 15,000 women of color, with 288 chapters in over 42 states. She attended Don Dear's Roast and shared they had a great time and she gave a toast instead of a roast. Last Tuesday, she was asked to join Mayor Robles from the City of Carson to do a press conference for Waste Resources where they unveiled their first all-electric trash truck. The next day, she attended LA County Sanitation District Collective Committee meeting in the City of Whittier, where the final vote was against a labor issue. Later that evening, she attended a Los Angeles Town Hall meeting held at Holman Methodist Church in opposition to Senate Bill 50. She asks that people research and do their homework on the Senate Bill and whether you are in favor or not in favor, to contact your local state senator, because it will affect everyone no matter where you live. The next day, she attended the 45th Annual Medal of Valor Ceremony and said she is very proud of our officers and appreciate the great things that they do. On Sunday, she attended a Pentecostal Missionary Church of God Dedication Ceremony for their upcoming 30th anniversary which will be celebrated on Sunday, June 2. She attended the Memorial Day service for the VFW Nisei Post 1961 held at the Japanese Cultural Institute.

He also attended the Medal of Valor Ceremony and said it's always great to see our officers being honored. He shared that Officers Avalos and Hernandez saved the life of a young child who was not breathing. On Memorial Day, he was invited to Palm Springs to give the opening prayer and benediction for a San Pedro Elks organization.
