MINUTES Regular Meeting of the City of Gardena City Council Tuesday, June 11, 2019

The regular meeting of the City Council of the City of Gardena, California, was called to order at 7:00 p.m. on Tuesday, June 11, 2019, in the Council Chamber of City Hall, 1700 West 162nd Street, Gardena, California; Mayor Tasha Cerda presiding.

City Manager Medrano gave a Power Point presentation.

There was a discussion which included Council Member Henderson, Mayor Pro Tem Kaskanian, Council Member Medina and City Manager Medrano regarding how we keep track of specific departments budgets, how alarm and permit fees are categorized, and if traffic and parking violations were included in our fees. City Manager Medrano replied each department has their own line items within their budget; they can do internal transfers as long as their financial bottom line doesn't change. He continued to say that alarm and permit fees fall into different categories; the fee schedule maintains waivers for low income users as well as senior citizens, and parking and traffic violations are fines imposed by the State of California; they are not included in our fees.

Hearing that there were no comments from the public, Mayor Cerda closed the Public Hearing at 8:51 p.m.

City Manager Medrano presented the Staff Report.

There was a discussion which included Council Members Medina and Henderson, Mayor Cerda and City Manager Medrano regarding recycling fees and if they would be deducted from the contract price; if a sign will be going up so our community knows we are using Prop C funds; and what happens if we don't use all the funds? Does that money go back to Prop C or can we use it for another project? City Manager Medrano replied when we put out the bid which included all of those, including the recycling clause, that are put into consideration. Yes, a sign will be going up letting our community know we are using Prop C funds; it is a requirement. He also confirmed that Prop C funds are allocated; we don't lose them. Those monies stay within our Prop C allocation.

C. <u>CITY MANAGER REMARKS RE</u>: <u>DIRECTIVES / COUNCIL ITEMS</u>

City Manager Medrano gave a verbal report of information to follow-up matters that had been directed or requested by the Mayor and Members of Council. Written reports had already been provided to the Council via copies in their regular mail packets. Those items are, as follows:

- (1) A Memorandum regarding Waste Resources Rate Increases;
- (2) Disposition regarding a complaint sent to Mayor Cerda; and
- (3) Police Officer Training follow-up report.

D. COUNCIL REMARKS

- (1) <u>COUNCIL MEMBER TANAKA</u> he reported that he attended the Cherrystone's Pioneer Project fund raiser for senior citizens. He attended the "Coffee with the Cop." Last, but not least, he attended the Los Angeles County League of California Cities meeting on June 6, 2019.
- (2) <u>COUNCIL MEMBER HENDERSON</u> since the last Council Meeting, he also attended "Coffee with the Cop" and complained that it was the most expensive Coffee with a Cop he has attended because it was held at Target and said that next time it should be held at a coffee shop which doesn't include shopping. He attended the Compton College Partnership Celebration with El Camino College and shared that Compton College has received their full accreditation and is now the 114th community college in the state of California. Compton College lost their accreditation many years ago, but El Camino College stepped in to help them get their accreditation back. He thanked the President of El Camino College for putting the parking structure on Manhattan Beach Blvd because that relieved pressure in their community with parking. He worked with Centinela Youth Services by helping them streamline some of their IT issues and said it was a great opportunity as a board member. He sent condolences to the family of the gentleman who lost his life, from the Council, and said he will let the judicial process work its way out and move forward after that.
- (3) COUNCIL MEMBER MEDINA since the last Council Meeting, he made his regular monthly cake deliveries. For the sake of transparency, he noted that Waste Resources Gardena donates the money to buy the cakes from Sam's Club. He said that the Rotary used to donate the money previously, but now Waste Resources provide the funds for the cakes and that he is just a delivery boy, delivering cakes once a month on the last Friday of the month. He attended the Southern California Association of Governments and announced that there will be new fees Metro Transit and said they will hold another meeting on Friday to discuss that. He went to the Veteran's Brunch in Hawthorne, where they celebrated the landing at Normandy. He said that there were a lot of veterans who had parents and family members who also landed in Normandy, and said it was very enlightening and very heartwarming. He attended the West Basin Water Association meeting and it was reported that California's water supply looks good and we are in great shape. He made a shout out to his granddaughter. Angelina, who comes over once every 3-4 months.
- (4) MAYOR CERDA since the last Council Meeting, she attended a Mayors Conference that Los Angeles Mayor Garcetti hosts every quarter; the main topic was Los Angeles County Fire Department's dealing with those in their department with PTSD and how they are handling the high rate of suicide among their firefighters. She attended the South Bay Workforce Investment Board's "Fit for Gold" Ceremony along with Council Member Medina. She presented several awards to seniors at Gardena High School who ...

... participated in the program by tutoring elementary school children, teaching them about nutrition. as well as working out with them. She also attended the Coffee with the Cop and shared the same concern as Council Member Henderson about the attractiveness of shopping at Target while there. She attended the funeral service for Los Angeles County Fire Battalion Chief Mark Tolbert, who worked for LA County for over 30 years and briefly worked at Gardena Fire Station No. 159. Lastly, she attended the Pentecostal Missionary Church of Christ (4th Watch), located at 182nd Street and Vermont Ave., as they celebrated their 30th anniversary and she thanked Chief Kang for attending the celebration with her.

(5) MAYOR PRO TEM KASKANIAN – said he also attended Coffee with the Cop but noted that he didn't spend any money. He said that he had an opportunity to meet with Supervisor Janice Hahn, along with his colleagues Mayor Cerda and Council Member Henderson, and reported that he asked her questions regarding the homeless, generally in the Los Angeles County area, and she responded that there were tremendous numbers, over 59,000 homeless in the County. He said he shared the numbers from our City and what kind of fees we pay to the State and said it was a very nice meeting.
