MINUTES Regular Meeting of the City of Gardena City Council Tuesday, September 24, 2019

The regular meeting of the City Council of the City of Gardena, California, was called to order at 7:00 p.m. on Tuesday, September 24, 2019, in the Council Chamber of City Hall, 1700 West 162nd Street, Gardena, California; Mayor Tasha Cerda presiding.

Interim City Manager Osorio presented the Staff Report. GTrans Director Ernie Crespo gave a PowerPoint Presentation.

Speakers: Kimberly Mason; Lyle Knight; Carolyn Torres, Souleil Helou; Sonya Jewitt; and Irish Liwanag.

There was a lengthy discussion, which included Mayor and Council Members, regarding the proposed service changes. Most of the speakers were parents who were opposed to the Line #3 service change in eliminating the morning and afternoon tripper that drops off and picks up students at Bishop Montgomery High School. These parents spoke about the hardship on their children if this line were to be eliminated; they felt the City of Gardena was making an irrational decision when all these children are doing is trying to get an education. No Bishop Montgomery High School representative was present. Director Crespo indicated that it was going to cost \$34,650 to keep this line going; he mentioned that the principal had offered \$15,000 to help subsidize the cost. There was also some discussion about fundraising in order to raise the money. It was agreed by Mayor and Council that Director Crespo would go back and meet with the school's representatives to see if they could offer more financial assistance. Two of the speakers spoke in opposition to Line #1X and asked Council not to go forward with the proposed changes. After hearing all the speakers, Council approved all the proposed service changes except for Line #3.

Interim City Manager Osorio presented the Staff Report.

There was a discussion, which included Council Member Henderson, Director Crespo and Interim City Manager Osorio, regarding the maintenance ongoing after the fifth year, and if we are scheduling any depreciation monies so when it's time for system replacement that money will be there; or will we get a new system at the full price? It was also discussed if we can ensure, as upgrades occur, that an interface of the payroll system can also get maintained. Council Member Henderson then asked if cloud solution discussions have been had. Director Crespo stated that GTrans hopes to have Tripspark much longer than six years. So, any money saved would be for the next upgrade and GTrans hosts it in the cloud; that their IT and payroll departments have been on board all along to see how it's going to tie into the city's servers. It was also discussed that the cloud is not always the best solution. Interim City Manager Osorio stated that, as far as the depreciation schedule, the City does depreciate assets, especially involving expenses such as these after seven years.

He attended the Keep Gardena Beautiful cleanup day and shared that all five of the Council got together and contributed to the cleanup and learned some planting skills in the process. He asked if they could adjourn the Council Meeting in the name of Rachel Ruiz Adam, who was a part of the Sister City Association and Cinco de Mayo Committee, along with many more community efforts. He asked to adjourn in the name of Karen Tankersley who passed away on September 15. She was a good friend of his who served with the Gardena Valley Lions Club.
- (2) MAYOR PRO TEM KASKANIAN since the last Council Meeting, he attended the 18th Anniversary of September 11 Memorial here at the Nakaoka Community Center. On the same day, he attended the Voting Solution for All People event put on by City Clerk Mina Semenza and Deputy City Clerk Becky Romero. He said he learned a lot and was very interesting. He said they talked about better ways to serve our community, balanced energy, transportation issues and economic problems, to name a few. He attended City Manager Medrano's farewell party and thanked Ed Medrano for all his hard work and wished him luck in what he does next. He attended the Gardena Beautiful Day cleanup, and thanked Stephany Santin and all who participated. He said he planted plants and hope they live. He thanked Jersey Mikes, Painters Tape, Rascals, and all the places that brought them food. She mentioned that the daycare is free for anyone who fits the income requirements, She shared that the daycare takes up to 50 kids and PACE spent over \$620,000 in remodeling the area to make it suitable for this program.

He shared that his goal as President of ICA was to expand beyond Los Angeles County. He thanked his colleagues for being supportive of him in his role in leading all the other ICA cities.
