

RESOLUTION NO. 6429

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
GARDENA, CALIFORNIA, APPROVING AND ACCEPTING THE
COUNTY OF LOS ANGELES' SUB-AWARD AGREEMENT FOR
CENSUS 2020 EDUCATION AND OUTREACH ACTIVITIES**

WHEREAS, the County of Los Angeles, a body corporate and politic, and a political subdivision of the State of California, hereinafter referred to as "County" and the City of Gardena, California, a municipal corporation, hereinafter referred to as "City" will enter into a sub-award agreement for Census 2020 Education and Outreach Activities; and

WHEREAS, pursuant to Government Code Section 3100 and Health and Safety Code Section 34149, the County of Los Angeles may enter into an agreement with the City to provide specialized functions on behalf of the County; and

WHEREAS, the County was awarded a total of \$9,393,090 in funding to conduct 2020 Census-related education and outreach activities, and to initiate targeted outreach strategies that focus on both geographic areas and demographic populations who are "least likely to respond" or "Hard-to-Count" (HTC); and

WHEREAS, areas and populations identified as "least likely to respond" and "HTC" are areas or populations which, based on multiple demographic, housing and socioeconomic variable factors, have been judged as difficult to enumerate by the California Department of Finance Demographic Research Unit; and

WHEREAS, on January 29, 2019, the County Board of Supervisors authorized the Chief Executive Officer to execute agreements with public entities, community-based organizations, and other entities to carryout 2020 Census-related education and outreach activities consistent with all State requirements; and

WHEREAS, the County grants to the City an amount not to exceed of \$ 34,105 to be used towards Census 2020 education and outreach activities that focus on both geographic areas and demographic populations who are "least likely to respond" or "HTC" within the City's local jurisdiction; and

WHEREAS, the City Council of the City authorizes and designates the City Manager to execute the County's sub-award agreement for an amount not to exceed \$ 34,105 to be used towards Census 2020 education and outreach activities that focus on both geographic areas and demographic populations who are "least likely to respond" or "HTC." within the City's local jurisdiction.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GARDENA, CALIFORNIA, DOES HEREBY FIND, DETERMINE, AND RESOLVE, AS FOLLOWS:

SECTION 1. The authorization and designation of the City Manager to execute the County's Sub-Award Agreement for an amount not to exceed \$ 34,105, and for such funds to be used towards Census 2020 education and outreach activities that focus on both

geographic areas and demographic populations who are "least likely to respond" or "HTC" within the City's local jurisdiction, is approved and accepted.

SECTION 2. The City Council hereby authorizes the City Manager or his designee to execute all necessary documents, on the City's behalf, to ensure compliance with the Sub-award Agreement and to conduct 2020 Census-related education and outreach activities.

SECTION 3. That this Resolution shall be effective immediately.

BE IT FURTHER RESOLVED that the City Clerk shall certify to the passage and adoption of this Resolution; shall cause the same to be entered among the original Resolutions of said City; and shall make a minute of the passage and adoption thereof in the records of the proceedings of the City Council of said City in the minutes of the meeting at which the same is passed and adopted.
