

RESOLUTION NO. 6593

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
GARDENA, CALIFORNIA, RECITING THE FACT OF THE
GENERAL MUNICIPAL ELECTION HELD ON JUNE 7, 2022
DECLARING THE RESULT AND SUCH OTHER MATTERS
AS PROVIDED BY LAW**

WHEREAS, a General Municipal Election was held in the City of Gardena, California, on Tuesday, June 7, 2022 and conducted by the Los Angeles Registrar-Recorder as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the Los Angeles County Registrar-Recorder/County Clerk canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GARDENA, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the whole number of ballots cast in the precincts (including provisional), except vote by mail ballots, was 1323; and

That the whole number of votes by mail cast in the City was 7647, making a total of 8970 ballots cast in the City.

SECTION 2. That the name of person voted for at the election of Mayor is as follows:

TASHA CERDA

That the names of persons voted for Members of the City Council are as follows:

WANDA LOVE
HAROUT (ART) KASKANIAN
RODNEY G. TANAKA

That the name of person voted for City Clerk is as follows:

MINA SEMENZA

and

That the names of the persons voted for City Treasurer are as follows:

SECTION 3. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates were as listed in Exhibit "A".

SECTION 4. That the City Council does declare and determine that: TASHA CERDA was elected as Mayor for the full term of four (4) years; RODNEY G. TANAKA was elected as Member of the City Council for the full term of four (4) years; WANDA LOVE was elected as Member of the City Council for the full term of four (4) years; MINA SEMENZA was elected as City Clerk for the full term of four (4) years; and GUY HAJIME MATO was elected as City Treasurer for the full term of four (4) years.

SECTION 5. That the City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: (1) The whole number of ballots cast in the City for the Council Member positions; (2) The names of the persons voted for; (3) For what office each person was voted for; (4) The number of

votes given at each precinct to each person; and (5) The total number of votes given to each person.

SECTION 6. That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

SECTION 7. BE IT FURTHER RESOLVED that the City Clerk shall certify to the passage and adoption of this Resolution; shall cause the same to be entered among the original Resolutions of said City; and shall make a minute of the passage and adoption thereof in the records of the proceedings of the City Council of said City in the minutes of the meeting at which the same is passed and adopted.
