- 4. Copy of lease or letter of agreement for use of property signed by the property owner (if applicable).
- 5. Evidence in the form of an official or government agency issued document or identification card that the applicant is eighteen (18) years of age or older or in instances involving alcohol sales, twenty-one (21) years of age or older.
- 6. <u>Applications for temporary use must be filed a minimum of twenty-one (21) business days before the desired start date.</u>

  No application shall be accepted and processed unless all of the required information is provided and completed.
