### APPROVAL OF MINUTES

A. January 13, 2020

a. Commissioner Dyson made a motion to approve the minutes, Commissioner Mathews seconded the motion. All were in favor. The Motion was passed and carried.

- A. Friends of Gardena Willows Wetland

### **UNFINISHED BUSINESS**

- A. In-Lieu Service Contracts
  - a. MOU Alliance Burton

Alliance Burton Technology Academy High School submitted a request to use Mas Fukai Park facilities for a tournament on March 7, 2020, and various dates in March and April (18, 25, 30, 22, 29). They are volunteering 40 hours in addition to the fees. Staffing charges were added; and lighting will be provided.

- B. Facility Upgrades
  - a. The ceiling in the Nakaoka Community Center auditorium will be painted this weekend. The floors will be redone on February 24-26, and maybe February 27. The senior meals program will be held in another room, or outside. Voting is taking place in the facility as well.
- C. Park Needs Assessments/Park Improvements
  - a. Some improvements will take place at Mas Fukai Park. Assessments are being done to determine the best approach for improvements to existing areas and for maximizing space. Depending on the condition of the building, it might be necessary to do a complete tear down and start over. Staff is also researching options to add a pickle ball court.

- presentation in the Recreation Division office for the new online software system. The new system will be used for online registration for classes, sports, facility rentals, special events, etc.
- b. Evette Benjamin presented the Civic Rec Software program. Staff will set up the system based on the needs of the department. One system will be used for everything. Clients will create a profile then they will have the ability to register online and pay fees. They will also have access to the calendars for facility rentals. Staff will still have the ability to assist if needed with paper registration especially during the transition period and any time after. Civic Rec Software was the most simplified system in comparison to the other two companies researched.
- c. Motion was made by Commissioner Dyson, second by Commissioner Mathews, all were in favor of the motion to recommend the selection of Civic Rec Software and that it be presented to City Council for consideration.
