 - 1) COUNCIL MEMBER FRANCIS First of all, I want to say congratulations to the Gardena Police Department and Deputy Chief for their leadership in being awarded the Lexipol award for the 5th straight year in a row. And congratulations to both the Public Works department as well as the City Clerk's department. We have an excellent staff and anytime we have an opportunity to say congratulations, for a job well done, we should. Thank you, Public Works, and thank you City Clerk. Since the last time we met, I attended the Gardena Beautification Commission meeting, the Greater Los Angeles Vector Control District meeting. I also attended the 39th annual Cinco De Mayo Parade and Cinco De Mayo Festival. So, I was a little concerned that because the weather was so gray and drizzly that folks might not come out, but we had the largest turnout for that parade; it was an excellent parade, and I got to ride in a really nice car. So, thank you and congratulations, Cinco de Mayo committee. Although it's not really celebrated

He had a place on Gardena Boulevard, and he was a photographer for the City that did almost everything for us. We lost Pat Worthy. She was on two of my commissions. And lastly, we lost Sam Kaskanyan from Sam's Autoland; he was way too young; another guy that would give you the shirt off his back if you needed it. And then lastly, I heard the Chief's leaving me, but congratulations on your extended time here and all the things you've accomplished.
