Environmental Consideration: Adoption of this ordinance does not qualify as a project per CEQA Guidelines section 15378 and is not subject to CEQA because there is no potential for any physical change in the environment. Even if CEQA were applicable, the adoption of this Ordinance would be exempt under CEQA Guidelines section 15061(b)(3) commonsense exemption as there is no possibility of any significant effect on the environment.

City Manager Osorio presented the Staff Report.

Planning Assistant Kevin La made a PowerPoint presentation. He noted for the record that a public comment was received regarding deed restrictions; after review, the ordinance was revised to remove the reference to deed restrictions to be consistent with state law.

Environmental Consideration: Adoption of this ordinance is exempt under the commonsense exemption of CEQA Guidelines sections 15061(b)(3) as it can be seen with certainty that there is no possibility that the adoption of this ordinance may have a significant effect on the environment.
